### Spotlight on Philanthropy: Educational Funding



AAUW has long supported educational opportunities as a strategy for empowering women and girls. Under the umbrella of Educational Funding, current programming provides educational and lifelong learning opportunities for women through fellowships and grants. Some are individual awards; for example, American Fellowships fund dissertations and postdoctoral research and Career Development Grants support career advancement, change, and renewal. One program – Community Action Grants – is open to individuals as well as AAUW branches and nonprofit organizations for innovative programs or research projects that advance equity for women and girls. According to the Web site, AAUW is providing more than \$3.7 million in funding during the current academic year. These educational opportunities are funded through individual and other donations to AAUW National. We at Lake / Sumter donate as a branch to Educational Funding from our budgeted monies.

### Local Scholarship Fund

While National AAUW's educational funding supports graduate and postgraduate women, Lake / Sumter AAUW's local scholarship fund focuses on undergraduate learners. Rosella Valentine chairs the local committee, and along with committee members Patti Weasel and Joyce Tisovec, she maintains a close relationship with Lake-Sumter State College (LSSC) in Leesburg, where our scholarship applicants are beginning their college careers. The committee solicits applications, reviews them, and selects recipients. Each year, our branch awards four (4) \$1,000 scholarships to students at LSSC. Two of these awards go to students who are completing their Associate's degree and will be transferring to a four-year institution to complete requirements for their baccalaureate degrees. The other two go to students who received one of the scholarships in the previous year and are continuing their programs, typically for a final year.

These scholarships are funded in part by dues income, but the lion's share of support comes from our annual jewelry raffle and bi-annual fundraiser. Also organized and managed by the local scholarship fund committee, the raffle features a piece of fine jewelry donated by Richie Kluesener of Gold in Art jewelers in Lady Lake. ### Summer Coffees/Breakfasts: Report from Jacquie Latzer

*Jacquie Latzer, facilitator for AAUW's Summer Coffees/Breakfasts in 2014 filed this report:*



Aside from hearing about the good works that AAUW does, one of the most often repeated comments I've heard since joining AAUW was how enjoyable and valuable the summer coffees were as a way to feel connected and get to know other AAUW women. But this summer an obstacle threatened to undermine this valuable activity: namely, all facilities that were previously available for free started to charge for room use.

Our Board, knowing how meaningful the coffees had been in the past, and confident that things would work out, selected Perkins Restaurant on Route 441 as the event site. The restaurant required the group to spend a minimum of \$75 each time we used their private room; if we didn't spend that much, then we would have to pay the room fee. So the plan went forward. Delightfully, every week between 15 and 22 women participated; and we promoted breakfast, instead of just coffee as in past years, as a way to ensure we covered the room cost. In addition, a donation box was present at each meeting and donations were encouraged for "just-in-case."

The coffees/breakfasts were held every Tuesday at 9:00 A.M. from June 3 through August 26, 2014. A question or topic was asked at each session to provide a jumping off point for members to share something about themselves. For example, members were asked, Where were you when President Kennedy was assassinated? Share an experience that changed your life (besides moving to The Villages). Share a time you were on the receiving end of a kindness.

We had great conversation and good sharing. . . and covered the room cost, so we never had to pay a room fee. Since the attendance was good, and our members generous, **we collected \$87.00** in the donation box. We gave this to the AAUW Board and turned a wonderful event into a mini fund-raiser as well. Truly a win-win. So it seems that what had appeared to be an obstacle, became an opportunity.

Additionally, some participants that had attended in previous years observed, that although they enjoyed the coffees, they were briefer and there was less time for sharing and getting acquainted. This year, because we ate breakfast, provided more time for interaction and sharing for the members. Again, another win-win.

Thanks to our Board for their confidence in us to find a way to continue this valuable activity, and thanks too for this opportunity to be of service. It was a most enjoyable time, and I am very glad for the chance to get to know y'all better.

Hot on the heels of a successful camp in 2014, preparations are well underway for launching the 2015 Tech Trek boot camp for girls entering eighth grade next summer. AAUW Florida has been selected to receive a \$10,000.00 AAUW Tech Trek grant award for 2014-15. This grant will allow the state to hold the camp for the third consecutive year, and Tech Trek 2015 will be held June 27 through July 3, 2015, again on the campus of at Eckerd College in St. Petersburg. Eighty young women have attended Tech Trek Florida so far and AAUW Florida officials hope to increase the number of participants in 2015 and have at least one camper representing each Florida branch.

Our branch Tech Trek committee will again be contacting local middle school principals, teachers, and parents to find the most qualified young students who can benefit from the total immersion in the STEM fields afforded to them during the one-week camp.
